

RustWho Terms of Service

1. Acceptance of Terms

These Terms govern access to and use of the RustWho website and application, called the Service. By creating an account or by using the Service, you accept these Terms and the Privacy Policy. If you do not agree, you must not use the Service.

2. About RustWho

RustWho is operated from the State of Kuwait. RustWho aggregates and organizes information that is publicly available from open source locations. The Service may also provide tools that let a user request data from external application programming interfaces. When a user uses such tools, the user acts as the party that sends the request, and the user is responsible for compliance with any terms that govern the external source.

3. Eligibility and Accounts

You must be able to form a binding contract under applicable law. You must provide accurate information, including a valid email and a password. You are responsible for all activity that occurs under your account, and you must keep your credentials secure. You must notify us promptly of any suspected unauthorized use.

4. Subscriptions and Billing

Paid features may require a subscription. Payments are processed by Stripe. RustWho does not collect or store full card data. Fees are stated at checkout. By starting a subscription you authorize recurring charges until you cancel. We may change prices with notice. Taxes may apply. Refunds are provided only where required by law.

5. Public Data and Display

RustWho displays information that is already public. RustWho does not claim ownership of public data. RustWho may cache results for performance and reliability. Display of public data on the Service does not imply affiliation or endorsement by the original source. If you want information to be removed, you may use the procedures in the Privacy Policy, including sensitive removal and full opt out options.

6. User Responsibilities, Lawful Use

You agree to use the Service only for lawful purposes. You will not infringe intellectual property or privacy rights. You will not attempt to circumvent access controls. You will not scrape or copy content in a manner that violates the terms of the original source. You will not upload malware or interfere with the operation of the Service. You will comply with all third party terms that apply to data or services you access through the Service.

7. Third Party Sources and Links

The Service may reference or link to third party sites or data. Those sites and data are not controlled by RustWho. RustWho provides no warranties about third party content. Your dealings with any third party are between you and that party.

You must not misrepresent your identity or your association with any person or entity. You must not use the Service for unlawful surveillance or harassment.

10. Content Removal, Takedown Requests

RustWho may remove content or suspend features in order to comply with law, to protect users, or to protect the Service. 11. Privacy

We may modify, suspend, or discontinue any part of the Service at any time, with or without notice. We may update these Terms from time to time. The updated Terms will be posted on the Service before they become effective. Continued use of the Service after the effective date means you accept the changes.

The Service is provided as is and as available. To the fullest extent permitted by law, RustWho disclaims all warranties, express or implied, including warranties of merchantability, fitness for a particular purpose, accuracy, and non infringement. RustWho does not warrant that the Service will be uninterrupted, secure, or error free.

15. Limitation of Liability

To the fullest extent permitted by law, RustWho will not be liable for any indirect, incidental, special, consequential, or punitive damages, or for any loss of profits, revenue, data, or goodwill, arising out of or related to your use of the Service. The total liability of RustWho for any claim shall not exceed the amount you paid to RustWho for the Service during the three months prior to the event giving rise to

You will defend, indemnify, and hold harmless RustWho and its officers, directors, employees, and contractors from any claim, loss, or expense, including reasonable legal fees, arising from your use of the Service, your violation of these Terms, or your violation of any third party rights.

17. Suspension and Termination

We may suspend or terminate access to the Service if we believe you violated these Terms, if we receive a request from a competent authority, or if your subscription is unpaid. You may stop using the Service at any time. Sections that by their nature should survive termination will survive, including ownership, warranty disclaimers, limitations of liability, and governing law.

18. International Use and Transfers

The Service may be accessed from countries other than Kuwait. You consent to the processing and transfer of your information outside your country as described in the Privacy Policy. You must ensure that your use complies with local law.

19. Governing Law and Venue

These Terms are governed by the laws of the State of Kuwait, without regard to conflict of laws rules. You agree to the exclusive jurisdiction of the courts of Kuwait for any dispute, and you waive any objection to venue in those courts.

20. Miscellaneous

These Terms are the entire agreement between you and RustWho regarding the Service. If a provision is found invalid, the remaining provisions remain in effect. Failure to enforce a provision is not a waiver. You may not assign these Terms without our consent. We may assign these Terms without your consent, for example in connection with a merger or sale.
